### **Rules for the design of the article:**

A4 page format. The text should be written: font-TIMES NEW ROMAN, size - 12, interval - 1 (single).

Page parameters: top and bottom -2 cm, right - 1.5 cm, left - 3 cm.

Tables and figures are embedded in the text of the article. In this case, the tables should have a title placed above the table field, and the figures should have captions. When using several tables and/or figures in an article, their numbering is mandatory.

The colors used in diagrams and should be distinguishable in a black-and-white image. Each drawing should be grouped.

**The text of the article is drawn up according to the following scheme:**

In the upper left corner of the text of the report, the UDC index must be affixed. After one interval in the center, the title of the article is indicated in bold capital letters. After an interval in the center, the surname and initials of the author, co-author (if available), academic title / degree, full name of the university, republic, city. After that, it is necessary to submit an abstract, in Kazakh, Russian and English, a list of keywords that fully reflects its content. After one interval, the main text begins.

It is necessary to fill out an Application (Appendix 1)

Materials provided later than the specified deadline or do not meet the requirements are not considered. Articles are not returned.
